17 Nov 1801 Deed: Heirs of Elijah Graves, dec'd -- Ralph Graves and Betsey B. Graves his wife, and Dolly Graves, and Robert Chandler and Lucretia his wife, John A. Finch and Nancy his wife, and Howel Graves and Elizabeth Graves his wife of Mecklenburg County, to **William Hendrick Jun.** of Mecklenburg County, £31 Virginia money, 28 acres in the forks adjoining Uriah Gregory, Eusebias Stone, Thomas Butler, and others.... /s/ John P. Finch, Ralph Graves, Nancy Finch, Betsey B. Graves, Hoell Graves, Dolley Graves, Elizabeth Graves, Robert Chandler, Lucretia Chandler. Witness: Mark Wilson, George Camp, Archibald Clark, John Green. 17 Dec 1801 Deed of Trust: **John Hendrick**, of Mecklenburg County, of the First part; John Hawkins, of Prince Edward County, of the Second part; and Haskins & Bilbo, merchants of Mecklenburg County, of the Third part: Whereas **John Hendrick** is indebted to Haskins & Bilbo for £25 and is desirous of insuring that the debt be paid, now for 5 shillings said **Hendrick** deeds to said Hawkins, trustee, 217 acres in Amelia County, adjoining Thomas Ligon, William Jones, **John Hendrick, Jr.**, Lewis Turner, James McGlasson, and **Garland Hendrick**, to be sold by said Hawkins for the benefit of Haskins & Bilbo if **Hendrick** does not pay the debt within the stipulated period... /s/ **John Hendrick**. Wit: Thomas Ligon, Daniel J. Manix. Acknowledged by **John Hendrick** on 14Jun1802 in Mecklenburg Court. (*Amelia County, VA, Deeds 21:237*)

This appears to have been John Hendrick, Carpenter, who had moved to Mecklenburg County. He was taxed on these 217 acres in Amelia as John Hendrick Sr. in 1800. In 1801 and 1802 he was a tax defaulter in Amelia on 217 acres. In 1814 the land was released on the application of one Edward Webster.

James Hendrick's wife was Mary Newton according to Will Hendricks. This family moved to Rutherford (now Cleveland) County.

28 Dec 1802 Deed: George Watkins of Chesterfield County, South Carolina to John Sizemore Jr. of Mecklenburg County, \$200 Virginia currency, 100 acres in Mecklenburg on the south side of Dan (sic) River near Sir Peyton Skipwith's ferry...beginning at **James Hendricks** line...Moss's line...Eppersons line...Sir Peyton Skipwiths line...Browders line...Tuck's line...Robert Glascock's line...Jackson's line... . . . [Mecklenburg County, VA, Deed Book 11, p299.]

11 Feb 1803 Deed: Richard Jones Jr. to **Thomas Hendrick**, both of Mecklenburg County, Virginia, £50 Virginia money, 200 acres “on the Poplar Branch [blank] sides of Grassy Creek... bounded by the lines of Thomas Greenwood, David Apperson, Martha Reamy, & Thomas Culbreath.” /s/ Richard Jones. Thomas Culbreath was the purchaser when Benjamin Hendrick sold out in Mecklenburg in 1788.

6 Apr 1803 Will: Eusebius Stone of Mecklenburg County. “...I give and bequeath to **William Hendrick Senior** all that tract of Land I bought of John Beavers which lies adjoining to the said **Hendrick** containing fifty acres...and bounded by the lines of John Hill, John Butler, and others... I give and bequeath unto Sally L. Vowells her maintenance during her natural life to be raised out of my estate... I lend unto my beloved wife Betty Johnson Stone all the residue of my estate not already willed...” After the death of his wife, half the estate to his wife’s brothers and sisters equally, and half the estate to his own brothers and sisters equally. /s/ Eusebius Stone. Witness: William Sadler, John Wood, John (x) Laneare. [Mecklenburg County, VA, Will Book 7, p61]

Stone and Hendrick were married to sisters according to Will Hendricks. “Eusebius” (spelled many ways) is one of those peculiar given names that flourished within one particular Stone family and their related families. There were several Stones carrying that name. It probably comes from Eusebius of Ceasarea, the first and most prolific historian of the early Christian church. William Hendrick of Mecklenburg had a grandson named Eusebius (son of James) and at least one great-grandson.

This is part of the 300 acre tract purchased in 1783. His son Thomas had just married Sarah Wall in December 1803.

William Hendrick's wife is probably deceased. Not only is no dower release noted in either the 1804 or 1805 deeds, but William Hendrick Sr. is selling the last of his land, as if he plans to be supported by a son.

This was probably a mortgage rather than a sale, as Will Hendricks says that John Hendrick eventually sold the land to someone else.

27 May 1839 Will of **Stephen Hendrick** of Mecklenburg County, Virginia: “I give and bequeath unto **George & Alexander Hendrick**, sons of **John J. Hendrick**, my negro woman Mehaly and her three children, to wit: Martha, Solomon & Swan & their future increase. Nevertheless I give the use of said Negro and their future increase to my son John J. Hendrick as long as he lives if he thinks proper to keep them in his possession(sic) for his own use only, but he may at any time, at his own option give them up to the said George & Alexander or their heirs if he thinks proper to do so...

I give and bequeath unto my grand children **William Hendrick**, **Thomas Hendrick**, and **John Hendrick** who are the children of my deceased son **Thomas Hendrick** the following negro. (viz.) Lewis. The said negro Lewis to be sold to the highest bidder & proceeds arising from the same to be equally (sic) divided between the aforesaid children & also one bond due from Hartwell W. Hargroove for Three hundred Dollars to be paid at the death of my wife, Mary Hendrick, which amount is to be equally(sic) divided between said children as aforesaid. The above mentioned is for the purchase of a negro boy named Wiley. If the said negro boy should die before my wife Mary Hendrick, then the above mentioned bond to be null & void if not to remain in full force & virtue. Also I give & bequeath all of my perishable estate to the three aforesaid children which is to be sold to the highest bidder & the proceeds to be equally(sic) divided between said children. In the event however that William, Thomas and John should die before they get the aforesaid property in possession then & in that case the same is to go to my Grand daughter Lucy W. Hargroove..."
